Depending on your individual experience and education, DWC board certification can be attained in as little as five (5) days. The DWC board certification is valid for five (5) years and does not demand expensive annual fees to maintain your status.

As a certified DWC clinician, your tested knowledge will set you apart from those who are not certified and only have minimal experience.
